1. Abide by all park rules including dog(s) on leash at all times unless specifically permitted off-leash to compete.
2. My Dog(s) is/are properly fitted with a "**belt buckle**" collar with current rabies tag attached. While participating in event(s), leads are to be no longer than 4 feet and attached to a "belt buckle" collar. Collar must be secure.
3. **No prong, choke or shock collars are allowed at any time on the event grounds.**
4. I will pick up my dog's poop as a courtesy to others, to prevent disease, and dispose of it in the trash cans provided on the property.
5. I agree to remove my dog(s) from the property if my dog(s) act aggressively towards other people and/or dogs, pose a safety risk to other people and/or dogs, and/or appear to be unhealthy, giving rise to health concerns.
6. The **HCCA "Be Mine" Dog Show** and their volunteers, agents, and sponsors, reserve the right to ask any person and their animal to leave the dog show at any time for any reason.
7. All children on premises must have adult supervision at all times.
8. Dogs can be held in a designated area with their handlers until called for participation in the scheduled contest.
9. There will be no "facing-off" of dogs, "challenges" or un-sportsman like conduct.
10. No animals in heat are allowed.
11. Inappropriate and/or disruptive human behavior will not be tolerated. Any dog showing aggression to humans or other dogs, or humans showing aggression to any dog or human, will be barred from participation and will be required to leave the premises upon notice to do so. No refunds will be given if you are asked to leave.

# Hold Harmless and Assumption of Risk Agreement

## HCCA "Be Mine" Dog Show, February 10, 2018

### Waiver of Liability:

I hereby acknowledge that I desire to participate in the **HCCA "Be Mine" Dog Show**, which you are entitled and defined in hereafter as "Dog Show Participant." I also acknowledge that my decision to participate as a Dog Show Participant is totally voluntary. I authorize the use of any photos, both digital and print, including postings for on websites and social media. Furthermore, I, the under-signed, hereby assume all risk of illness or injury as a Dog Show Participant in which I voluntarily participate. For and in consideration of permission to participate as a Dog Show Participant, I hereby irrevocably and forever release, discharge, waive, and hold harmless the **Hollywood Council of Civic Associations (HCCA)** and their officers, directors, employees, sponsors, and volunteers (collectively referred to as "**HCCA "Be Mine" Dog Show"**) from any and all claims, losses, causes of action and liabilities of any kind (including attorney's fees) arising out of or relating in any way as a Dog Show Participant. I voluntarily waive any claims that I might have against the **HCCA "Be Mine" Dog Show**, and I understand and agree that the **HCCA "Be Mine" Dog Show** assumes no responsibility or liability for any injury to persons or property (including property that is lost, stolen or damaged), that may occur. I agree that I am at least 18 years of age and am bound by all the terms of the Hold Harmless and Assumption of Risk Agreement. I agree this instrument, in its entirety, is intended by me to be binding upon my heirs, executors, administrators, agents, and/or assigns.

I, the undersigned, certify that I am the actual owner of the dog, or that I am duly authorized agent to the actual owner. I agree to abide by the rules and regulations of the Sanctioning body, the HCCA "Be Mine" Dog Show, and acknowledge violations of same, will result with the forfeit of the dog(s) participation and entry fee. I personally assume all responsibility and liability for this dog(s) and hold harmless the HCCA and all other parties from any claim, loss, or injury. I agree that all dog(s) are current on all vaccinations. It is understood that every dog at this event will at all times be in the care and control of the dog's owner or handler. It is further understood that the undersigned handler agrees to be fully responsible for the actions of the dogs in his/her care while on the event grounds. I agree to hold HARMLESS the **HCCA "Be Mine" Dog Show**, as well as their members and officers and directors and all owners of property upon which the event is being held for the loss or injury which may have been caused directly or indirectly to any person or myself, including death, or property, including my property, by any act of, a dog while in my care, while on the event premises. I hereby assume all responsibility and liability for such claims. I further relinquish and waive all claims and agree to hold HARMLESS the **HCCA "Be Mine" Dog Show**, their members, officers and directors and all owners of property upon which the event is being held for loss to property, including my property and/or injury to any person or myself, including death, which may have been caused directly or indirectly to myself or a dog while in my care during participation in this event.

The undersigned recognizes that participation in dog show events may result in unanticipated injuries to a participating minor. Notwithstanding the foregoing, the undersigned, is requesting the right to participate in a dog show. Therefore, in consideration of permitting the undersigned or as representative if participant is a minor, to participate in the dog show, and for other good and valuable consideration, for themselves, their heirs and spouses, legal representatives, administrators and executors, do hereby release and hold harmless the **HCCA "Be Mine" Dog Show**, its officers, directors, judges of the event, employees and sponsors from and against any injury, claim, damages, expense, cost, loss of service on account of, or in any way growing out of, participation in the dog show/trial. The undersigned agrees to indemnify the **HCCA "Be Mine" Dog Show** and each of them from, and waive, any loss, liability, claim, damage or cost, including but not limited to the risk of bodily injury that may be sustained by the undersigned, minor, or spectator with respect to participation in said dog show/trial, and the undersigned agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of Florida.
